# Privacy Policy for An Average Game LLC

#### 1. Information Collection and Use

# 1.1 Google Login Information

When you log in using Google, we receive limited information from your Google account, such as your username, email address, profile picture, and unique user ID. This data is used for authentication and providing functionality during your session.

### 1.2 Payment Information via Stripe

We use **Stripe** for secure payment processing. When you make a purchase, Stripe collects and shares with us the following information:

#### Customer Information:

- o Name
- o Email address
- Billing address
- Shipping address (if applicable)
- Phone number (if collected during checkout)

#### Payment Information:

- Card type (e.g., Visa, Mastercard)
- Last four digits of your card
- Card expiration date
- o Payment method type (e.g., credit card, Apple Pay, Google Pay)

# • Transaction Details:

- Amount paid
- Currency used
- Transaction date and time
- Payment status (e.g., succeeded, failed, refunded)
- Refund history (if applicable)

#### • Subscription Details (if applicable):

- Subscription plan details (e.g., name, price, billing interval)
- Trial period status (if any)
- Upcoming invoice dates

### • Customer Interaction History:

- Transaction history for the user within An Average Game LLC
- o Dispute and chargeback communication logs

### Dispute/Chargeback Details (if applicable):

- o Reason for disputes or chargebacks
- o Evidence submitted to Stripe for resolution

#### • IP Address and Device Information:

 Stripe may collect and share your IP address and device type for fraud prevention and security purposes.

This information is used solely for processing payments, managing subscriptions, handling disputes, and providing customer support.

### 2. Data Storage and Protection

#### 2.1 Data Storage

- Google Login Information: We use Google login to authenticate users and provide access to the Services. The information provided by Google (e.g., email address, username, and unique user ID) is securely stored within our authentication system for managing your account and session. This data is not used or stored outside of authentication purposes.
- Payment Information: Sensitive payment data is handled securely by Stripe. We store limited
  information in Firebase, including your name, billing address, and the last four digits of your
  card, for transaction and customer service purposes.

#### 2.2 Data Protection

We implement industry-standard security measures, including encryption and secure storage, to protect your personal data. However, please note that no security system can guarantee complete protection.
